In 48 years of its existence, KSFDC, the first public sector undertaking in India, for the development of the film industry has crossed many milestones. The Chitranjali Studio Complex, inaugurated in 1980, is truly a pioneer in introducing the latest film technology in South India. A large number of films made here have earned national and international accolades. KSFDC also owns an exhibition network with 17 screens spread all over Kerala.

Chitranjali studio has all the advanced facilities for film production and post-production like dubbing, Foley recording, sound editing, sound mixing, Sync sound recording, Film Editing, DIGITAL INTERMEDIATE (DI), Shooting floors, Green matte, Film museum, permanent shooting sets, shooting locations, landscape, apartments, etc and with the completion of ongoing 150 crore modernisation project, Chitranjali studio is all set to become film factory of SAARC countries.

An OTT platform showcasing curated contents is the latest project of KSFDC. The proposed OTT Platform will be the first Government owned OTT Platform in India.

3. OBJECTIVE OF THE INVITATION FOR EOI

KSFDC is looking for firms/consultants who can offer legal advice and Business Operations support for the upcoming OTT platform.

Scope of work:

The selected firm/consultant shall be responsible for

- 1) Drafting/vetting of contracts.
- 2) Conduct desk study of relevant policy documents, guidelines and plans at national, regional and continental levels on regulatory interventions on OTTs and the related consumer protection laws and frameworks.
- 3) Review the existing documents (policies & strategies, rules) related to OTTs regulatory environment, taxation regimes and privacy concerns.
- 4) Undertake cost/benefit analysis and consultations with regional organisations and relevant stakeholders.
- 5) Provide extensive support for customization and branding of the OTT platform.
- 6) Developing Business strategies and monitoring operation planning.

4. REQUIRED QUALIFICATIONS AND SKILLS

- 1) The firm/consultants should have professionals on board having a Degree in law from a recognized university and specialization in IPR.
- 2) Broad knowledge of existing regulations in connection to streaming
- 3) Experience in producing films, web series and content for television
- 4) Work experience in executing capacity in leading OTT platforms/media houses
