The Chitranjali Studio complex, inaugurated in 1980, is truly a pioneer in introducing the latest film technology in South India. A large number of films made here have earned national and international accolades. KSFDC also owns an exhibition network with seventeen screens spread all over the major cities of Kerala. KSFDC also operates C Space, the only Government owned OTT platform in the country. With the imminent completion of the Chitranjali Studio Modernization Project Chitranjali will transform into a filmmaking hub of SAARC countries.

# **About The project**

KSFDC website <a href="https://www.ksfdc.in">https://www.ksfdc.in</a> was created two decades back. It lacks several features that a modern website should have and therefore the site needs to be redesigned in tune with the most sophisticated artistic/design values, employing ergonomic design principles and utilizing state of the art technology employed in website designing. The website through its look and feel and user experience should represent KSFDC as a pioneer in promoting the art, business and technology of not just filmmaking but the entire spectrum of AVGC-XR.

The firms submitting the EOI for redesigning KSFDC website should also have the capability to offer web hosting and maintenance and operational support. Preference will be given to firms that employ designers who received training from leading design/art schools of the country like National Institute of Designs.

## **Procedure of Selection**

➤ Interested firms may submit the EOI on or before 20/08/2025 to Managing Director, Kerala State Film Development Corporation (KSFDC) Ltd.

The EoI Should Contain the following documents.

- Company Profile, Registration certificate and authentication certificate
- GST Registration Details, PAN Details
- Details of Previous work with work order and customer satisfaction certificate
- Work Plan Proposal
- ➤ The EoI submitted will be evaluated by the Evaluation Committee/IT Committee constituted by KSFDC. Selected Candidates will be invited for meeting and presentation of the Plan Proposal.
- ➤ Based on the meeting quotations will be received in 2 cover system (Technical Bid and Financial bid).

#### **Short Listing Criteria**

KSFDC will shortlist bidders who meet the Prequalification Criteria, experience in execution of similar projects and evaluation of demo to be given by the eligible bidder before the Evaluation Committee of KSFDC. The shortlisted bidder will be intimated to submit their technical proposal along their financial bid.

#### **Evaluation Criteria**

The Evaluation Committee constituted by KSFDC shall evaluate the EoI and all supporting documents and documentary evidences. Inability to submit requisite supporting documents or documentary evidence may lead by rejection of the EoI proposal. The committee may seek additional documents as it deems necessary.

The bidder will be required to make a presentation before the Proposal Evaluation Committee on technical and operational aspects including the demonstration of their previous work experience.

The technical Bid proposal has a weightage of 70% and the financial bid proposal has a weightage of 30%. The technical bid weightage will be calculated on the basis of marks scored in the technical presentation and the assessment based on the technical proposal submitted along with this BOQ.

#### **Financial evaluation Criteria**

The lowest evaluated financial proposal (FM) is given the maximum financial score (SF) of 100. The formula for determining the financial score (SF) of all other proposals is calculated as follows.

SF=100\*FM/F

F- Price of the proposal under consideration

#### **Technical evaluation Criteria**

The highest evaluated technical proposal is given the maximum Technical score (St) of 100 and lesser evaluated technical proposals are given lower Technical score accordingly.

#### **Consolidated Evaluation**

The weights given to the Technical (T) and Financial Proposals (P) are

T=0.70 and P=0.30

Proposals will be ranked according to their combined technical (St) and financial (Sf) scores using the weights as follows

S=St\*T%+Sf\*P%

The firm achieving the highest combined technical and financial score will be invited for negotiations.
