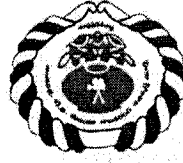

You are kindly aware that Andhra Pradesh state is having very attractive natural shooting locations like Araku Valley, Borra Caves, Belum Caves, Forest, long coast line with sun-lit beaches, Horsley Hills, etc. These locations are well connected by Air, road and rail. Further decent accommodation facilities are also available within the vicinity of these locations.

In order to establish film industry in the State, the Government decided to allot shooting locations without charging any fee, however a fixed amount has to be paid by the producer as Caution Deposit, which will be refunded to producer immediately on production of shooting completion letter from the location incharge and accordingly issued G.O.Ms.No.45, G.A. (I&PR.II) Department dated 19.5.2020. Copy enclosed for your ready reference.
